The estimated amount for the works is Rs. (in NRs) 2602140.37 (Exclusive of VAT and Contingencies).

5. electronic bids must be submitted to the office Nisdi Rural Municipality, Palpa Lumbini Province, Nepal through PPMO website [www.bolpatra.gov.np/eng](http://www.bolpatra.gov.np/eng). On or before 21-02-2024 12:00. Bids received after this deadline will be rejected.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 21-02-2024 13:00 at the office of Nisdi Rural Municipality, Palpa, Lumbini, Province, Nepal.

Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.71000, which shall be valid for 30 days beyond the validity period of the bid.
