- 1 The Nisdi Rural Municipality invites electronic bids from eligible bidders for the procurement of Complete Installation and transportation of 50 watt solar home system with solar module 50 watt, solar charge controller, 35 AH battery, LED bulb, Bed switch, Bulb Holder, Panel stand, 1 sqm wire and UV cable.(as per site engineer Instruction) under National Competitive Bidding procedures specified in Public Procurement Act and Regulations.

5. electronic bids must be submitted to the office Nisdi Rural Municipality, Palpa Lumbini Province, Nepal through PPMO website www.bolpatra.gov.np/eng. On or before 19-01-2024 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 19-01-2024 13:00 at the office of Nisdi Rural Municipality, Palpa, Lumbini, Province, Nepal.
Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.51000, which shall be valid for 30 days beyond the validity period of the bid.
